NOTIFICATION

In cancellation of all earlier communications made by this Department with regards to formation of West Bengal Joint Entrance Examination Board for conduct of common entrance examination for admission into the undergraduate courses of Engineering & Technology as well as Medical Education in the State of West Bengal *along with* formation of Central Selection Committee (Engineering & Technology) for allotment of successful candidates in the aforementioned entrance examination into various Engineering & Technology as well as Pharmacology Departments and Institutes of State-aided Universities, Government Engineering & Technology Colleges and other Self-financing Engineering & Technology as well as Pharmacy Colleges in the State of West Bengal; the Governor is pleased to re-constitute the erstwhile *West Bengal Joint Entrance Examinations Board* (established in 1962) in the following manner by merging erstwhile *Central Selection Committee (Engineering & Technology)* (established in 1981) with it. After re-constitution of the *West Bengal Joint Entrance Examinations Board* the erstwhile *Central Selection Committee (Engineering & Technology)* shall cease to exist.

The re-constituted *West Bengal Joint Entrance Examinations Board* shall *conduct common entrance examination for admission into the undergraduate courses of Engineering & Technology as well as Medical Education in the State of West Bengal along with allotment of successful candidates in the aforementioned entrance examination into various Engineering & Technology as well as Pharmacology Departments and Institutes of State-aided Universities, Government Engineering & Technology Colleges and other Self-financing Engineering & Technology as well as Pharmacy Colleges in the State of West Bengal* and shall have following constitution.

1. The re-constituted Board shall discharge its functions in consonance with the existing *rules of business followed by the Board since inception* and would be performing its duties accordingly;
2. The existing employees of the Central Selection Committee shall be absorbed against existing vacancies of the Board in suitable capacities. Creation of the said vacancies in the Board was done in concurrence with the Finance Department through the Department of Higher Education and the Appointing Authority of these posts/vacancies is the Board and executed through its Chairman. Therefore the re-constituted Board is empowered to regularize these absorption through decision adopted in its meeting following the financial & service rules in vogue;

3. The merger of the Central Selection Committee (Engineering & Technology) should be well publicized with information to all concerned;
4. The activities of the Central Selection Committee (Engineering & Technology) shall be conducted by the Board directly, in future;
5. The funds and books of accounts of the Central Selection Committee (Engineering & Technology) shall also be merged with the Board after the Cash Analysis of both the Board and the Committee has been made with the help of the existing Auditor and under supervision of the Board;
6. All movable and immovable assets as well as liabilities of the Central Selection Committee (Engineering & Technology) will become the property of the West Bengal Joint Entrance Examination Board subsequent to the Notification along with the legal liabilities. Therefore the existing and pending legal cases e.g. court-cases of the Central Selection Committee (Engineering & Technology) will henceforth be dealt with by the Board;
7. The Board shall frame its Budget as has been done earlier and meet all sorts of expenditure out of the income of the re-constituted Board. No subsidy from Government shall be given to the Board for its maintenance;
8. The Board shall maintain the Accounting procedure in consultation with the Accountant General, West Bengal, pending which the Government Audit and Accounting procedures shall be followed;
9. The Accounts of the re-constituted Board shall be subject to Government Audit besides the Board shall submit yearly Budget and Income-Expenditure Statements to the State Government in the Higher Education Department.

All concerned are informed accordingly.
